*The **Academic Course Evaluation** form is made available **online** at **e-Course Evaluation System (eCevas)** accessible at <http://umis.uum.edu.my>. Students are given a period of **ONE MONTH (30 DAYS)** to complete the evaluation, that is, before the commencement of the examination period for each semester.*

*Students who do not comply with this requirement and complete the course evaluation process will **NOT** be able to obtain their sitting examination slip.*
